

**RESOLUTION 20-44**

**A RESOLUTION OF THE GOVERNING BOARD OF THE  
SANTA CLARA VALLEY OPEN SPACE AUTHORITY  
AUTHORIZING THE GENERAL MANAGER TO ENTER INTO  
CONTRACT WITH CYCLONE FENCE & IRON, INC. FOR INSTALLATION OF PERIMETER FENCING AT  
PAJARO RIVER AGRICULTURAL PRESERVE**

**WHEREAS**, fencing is required to delineate a boundary between resource management areas and agricultural fields on the northern portion of the Pajaro River Agricultural Preserve; and

**WHEREAS**, the Authority requires the services of a Fencing Contractor to perform fencing installation services to construct approximately 2,400 linear feet of chain link fencing and four (4) swing gates; and,

**WHEREAS**, the Authority prepared and posted a Request for Bids (RFB) on the Authority's website and at the Administration Office window on June 19, 2020. The RFB was published on three local exchanges that perform such services. The RFB was also emailed to at least three (3) firms who perform such services; and,

**WHEREAS**, five (5) bids were submitted; and,

**WHEREAS**, Cyclone Fence & Iron, Inc. submitted the lowest responsible bid at a Base Bid of \$53,384.52; and,

**WHEREAS**, Staff recommends that the Board award the contract for the Pajaro River Agricultural Preserve Perimeter Fence Installation Project to Cyclone Fence & Iron, Inc. as the lowest responsible bidder; and,

**NOW, THEREFORE, BE IT RESOLVED**, that the Board authorizes the General Manager to enter into a contract with Cyclone Fence & Iron, Inc. to provide fencing services in the base bid amount of \$53,384.52 plus the amount of any additive and deductive alternates set forth in the bid as determined by Staff to be necessary to complete construction as per the bid documents and the Board also authorizes the General Manager to approve any necessary change orders up to 10% of the base bid amount.

**BE IT FURTHER RESOLVED**, that the Board further directs that the General Manager is hereby authorized and directed, on behalf of the Authority and in its name, to execute and deliver said contract and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.
