# Llagas Creek Bridge and Day Use Area Project Recommended Board Actions

### **Project Goals**

- Expand public access at existing open preserve.
- Install a bridge over Llagas Creek to provide improved access (public and operational) to meadow day-use area and former Blair Ranch property. Abandon ford through creek.
- Create an accessible interpretive trail and dayuse area at south meadow.
- Provide flexible use areas to accommodate a variety of environmental education programs.







#### Project Map

- In-Stream Avoidance and Minimization
- Minimization of Ground Disturbance and Revegetation Post-construction
- o Fuel Buffers
- Preconstruction Surveys
