Disability Statistics

American Community Survey (2014)

- 27.2% of the population (85.3 million people) have a disability
- **17.6%** of the population (55.2 million people) have a severe disability
- People 75 years and older are 5x as likely to have a disability as people 18-24 years old




Americans with Disabilities Act


The Americans with Disabilities Act (ADA) is a civil rights law that mandates equal opportunities for individuals with disabilities.

Title II requires ADA Self-Evaluation and Transition Plan.

Barrier Removal by Project Type

Barrier Removal Type	Timeframe	Description
Interim Solutions	1 – 5 Years	Interim measures in place pending major barrier removal projects
Maintenance Improvements	1 – 5 Years	Completed in-house (e.g., new signage, relocating grab bars, minor regrading) <\$5k each
Small Capital Improvements	1 – 10 Years	Completed in-house or by contractor <\$50k each
Large Capital Improvements	1 – 15 Years	Completed by contractor >\$50k each



"With the disability community, novel solutions can be created especially if we think outside the box. As those with disabilities feel comfortable and listened to, you will have more feedback to include in your programs."

"Going beyond standard ADA thresholds to an even more diverse series of physical and programmatic offerings to as wide a variety of disabilities as possible... invite people with lived experiences to review."
